

Also issues often (and sometimes not so often) seen in assessment and case practice. **Group One** caters for practitioners closer to the 'starting-out' phase of their career, aimed at those in the first 2 to 3 years of their careers in Sexually Harmful Behaviour Treatment. **Group Two** is for practitioners with more experience – anywhere from 3-plus years to 20-plus years-experience. **Six** 90-minute fortnightly sessions. **Maximum** of <u>6</u> participants guarantees the space and the time for each participant to contribute in any way they wish (discussing, presenting case components or simply listening).

Russ Pratt facilitates 4 sessions in each group,

Kevin Creeden and Jim Worling facilitate 1 session each.

This is a unique opportunity to engage with acknowledged experts in the field. If you are assessing and/or treating HSB issues, its most likely you are using, or have used, assessment tools produced by Jim, and using treatment techniques either developed or enhanced by Kevin.

Sessions commence in early March and run fortnightly.

Dr. Worling is a Fellow of the Association for the Treatment of Sexual Abusers, and he serves on the editorial boards for the journals Sexual Abuse and Sexual Offending: Theory, Research, & Prevention.

Kevin Creeden, M.A., LMHC is the Director of Assessment and Research at the Whitney Academy in East Freetown, MA. He has over 35 years of clinical experience treating children, adolescents, adults and families and working extensively with sexually and physically aggressive youth. Over the past 25 years, his primary focus has been on issues of trauma and attachment difficulties and he has authored several articles and book chapters on the neurodevelopmental impact of trauma on children and adolescents with sexual behavior problems. Mr. Creeden was also a member of the committee that developed the Adolescent Treatment Guidelines for ATSA (The Association for the Treatment of Sexual Abusers). He has served as the president of the Massachusetts chapter of the American Professional Society on the Abuse of Children (APSAC), and was a Teaching Fellow at Boston College, an Instructor in Psychology in the Department of Psychiatry, Harvard Medical School, and guest faculty at the Boston University School of Social Work. Presently, Mr. Creeden is the Board Chair of MASOC and a guest faculty at the Simmons School of Social Work Advanced Training Program in Trauma-Focused Treatment. Mr. Creeden trains and consults nationally and internationally to schools, youth service, community, forensic services and mental health service agencies.

# ABOUT DR RUSS PRATT

Dr Russ Pratt has over 20 years' experience working therapeutically with sexual assault and abuse, trauma, attachment, family systems and child protection issues. He has been the Director of Prime Forensic Psychology since 2017. From 2010 until 2017 he was one of two Statewide Principal Practitioners with the Victorian Department of Health and Human Services Child Protection program. Prior to that he was manager and senior clinician of the AWARE program for sexually abusive youth at SECASA. He holds specialist registration as both a Forensic and Counselling Psychologist. He was a member of the Therapeutic Treatment Board (a Ministerial appointment) from 2012 to 2017, is a current ANZATSA board member, a Fellow of ATSA (USA), and a board member of the National Adolescent Perpetrator Network (USA). Russ recently wrote the ATSA fact sheet 'Understanding and Responding to Pornography Use Among Adolescents who have Engaged in Sexually Abusive Behavior: Facts and Considerations for Practice'. Russ regularly writes and presents both nationally and internationally regarding youth exhibiting Harmful & Problem Sexual Behaviours, the impacts of pornography on sexual practice, and other issues. He can be seen and heard regularly on podcasts, in print, and on television and radio, and is a popular interviewee and speaker on the topics of sexual abuse, pornography and trauma.
